## **H.E Mohamed Ennaceur**

President of Tunisia

Mohamed Ennaceur, (born 21 March 1934) is a Tunisian politician who became interim President of Tunisia on 25 July 2019, upon the death of President Beji Caid Essebsi. Since 2014, he has been the President of the Assembly of the Representatives of the People and leader of the governing Nidaa Tounes party. Previously, he served as Minister of Social Affairs in the 1970s and 1980s under President Habib Bourguiba and again in 2011 in the transitional Ghannouchi and Essebsi governments.

Ennaceur was the founding director of the Tunisian Association of Social Law (Revue tunisienne de droit social) and the Festival international de musique symphonique d'El Jem.

On 4 December 2014, he was elected as President of the Assembly of the Representatives of the People, with 176 yes votes out of 214 present MPs. Upon President Beji Caid Essebsi's death, Ennaceur ascended as interim president according to the Constitutional provision for presidential succession.

He sits atop a major conglomerate and financial empire with stakes in real estate, construction, oil and gas, energy, engineering, agriculture, and technology, for close to two decades. At Tilt Group of Companies, he is charged with the responsibility of boosting revenue and performance while mitigating possible risk by overseeing policy and procedure enforcement, employee teams, and financial metrics.

Under Mr. Okunola's leadership, Tilt Group has witnessed rapid growth and diversification, which has made the conglomerate become a renowned public/private sector contractor with

several ongoing projects for the Nigerian Airforce, Army, Immigration, Defence

Intelligence Agency, amongst others.

He is a certified businessman of international repute, whose experience in conceiving business transactions have given him access to Presidents, Prime Ministers, and leaders of International organisations. Over the last decade, his philanthropical gestures has impacted millions of undeserving people all over Africa most especially in the area of Education, Health, Financial Inclusion, State Security & Prison Reforms. This is a testimony to his favourite saying, "empowerment is proof of wealth".

Having graduated with a degree in Philosophy from the University of Lagos, Mr Habeeb has since attended several executive leadership and management programs at Harvard Business School and numerous institutions home and abroad; which has given him the opportunity to learn, unlearn and relearn fast evolving best practices; and build his network of friends and business partners, which he leverages on.

Mr Habeeb Olalekan Okunola prides himself as a firm advocate of sustainable development at the grassroots.



### **H.E Adama Barrow**

President of the Republic of Gambia

Adama Barrow (born 16 February 1965) is a Gambian politician and real estate developer who is the third and current President of the Gambia, in office since 2017.

Born in Mankamang Kunda, a village near Basse Santa Su, he attended Crab Island Secondary School and the Muslim High School, the latter on a scholarship. He then worked for Alhagie Musa & Sons, a Gambian energy company, where he became a sales manager. Moving to London in the early 2000s, Barrow studied for qualifications in real estate and concurrently worked as a security guard. After returning to the Gambia in 2006, he founded Majum Real Estate, and was its CEO until 2016. He became the treasurer of the United Democratic Party, an opposition party, and then became its leader in September 2016 after the previous leader was jailed.

Barrow was then chosen as the UDP candidate in the 2016 presidential election. It was later announced that he would stand as an independent with the backing of the opposition group Coalition 2016 (a coalition supported by the UDP and six other parties).



## Hon. Dr. Mrs Fatoumata Jahumpa-Ceesay

Former National Speaker, the Gambia National Assembly

Born on 25 October 1957, she attended Method Primary School and Crab Island Junior Secondary School before proceeding to Armitage High School and later Gambia High School where she completed her secondary education in 1977. She obtained a Higher Diploma Certificate in Print Journalism at the Centre for Foreign Journalists in Reaton Virginia, USA in 1996. In 2010 attended the Kofi Annan Institute in Ghana. Also attended local and international training and courses leading to Certificates in Journalism, Public Relations, Peace & Conflict Resolution, Election Observations and Diplomacy Mrs Jahumpa Ceesay's career began with her employment as an Announcer at Radio Gambia. She later joined The Gambia Airways Limited where she rose to the position of Cargo Supervisor and Corporate Relations Manager.

In April 1993, Mrs. Jahumpa Ceesay joined the Daily Observer and the Point newspapers as a freelance journalist. She was a columnist for the Family Focus, Women, Children and Political issues. She thereafter had a stint with Citizen FM radio as News Anchor/Producer, responsible for the presentation of Women programs in 1995. In recognition of her commitment to women and youth development, she was appointed by the former President of the republic of the Gambia Alhaji Sir Dawda Kairaba Jawara a Lady Councilor at the Banjul City Council in 1985 and became the first woman Deputy Mayor of the city, Banjul in 1989.

In 1997, she was appointed Director of Press and Public Relations at the Office of the President of the Gambia. She held this post until H.E. President Sheikh Prof. Dr. AlhYahya A J J Jammeh nominated her as a Member of the National Assembly in 2002. 2003-2005 she was elected to the West African Community Parliament (ECOWAS Parliament) and became the first woman in West Africa to become a Deputy Speaker in the ECOWAS Parliament. Hon Fatoumata Jahumpa Ceesay was also founder member and Coordinator of the Economic Community of Female Parliamentarians Association (ECOFEPA).



## H.E Joao Manuel Goncalves Lourenco

President of Angola

João Manuel Gonçalves Lourenço, GCollH (born 5 March 1954) is an Angolan politician who has served as the President of Angola since 26 September 2017. Previously, he was Minister of Defence from 2014 to 2017. In September 2018 he became the Chairman of the People's Movement for the Liberation of Angola (MPLA), the ruling party. He was the party's Secretary-General from 1998 to 2003.

João Lourenço was designated in December 2016 to occupy the party's number 1 position in the August 2017 legislative election. In terms of the 2010 constitution, "the individual heading the national list of the political party or coalition of political parties which receives the most votes in general elections... shall be elected President of the Republic and Head of the Executive". As the MPLA won a majority of 150 seats, Lourenço automatically became President of Angola, succeeding José Eduardo dos Santos, in power for 38 years. Lourenço was officially sworn into office on 26 September 2017.



Mokgweetsi Eric Keabetswe Masisi (born 21 July 1961) is the fifth and current President of Botswana, serving since 2018. He has also served as Minister of Education since 2014, and previously he was Minister of Presidential Affairs and Public Administration from 2011 to 2014.

He was first elected to Parliament in 2009. Mokgweetsi Masisi is the son of Edison Masisi (1923–2003), the long-time MP for Moshupa and many-time cabinet member. The younger Masisi grew up in Gaborone, attending Thornhill Primary School and Maru A Pula School. In school he competed in soccer and tennis, but ultimately found acting to be his calling.

In 1984 he won acclaim for his portrayal of the lead role in a Gaborone production of Cry the Beloved Country, and was praised by the visiting Alan Paton for his performance. During the 1980s he starred in numerous theatrical productions, and also had roles in South African B-Movies.



## **Henry Bolton OBE**

Leader of our National Party of Great Britain

Henry is British politician, former British Army Infantry and Intelligence Officer, Police Officer and International Diplomat.

Links to Africa

Henry has a deep emotional commitment to Africa. His grandfather is buried in Malindi, Kenya. His father was born there, as were both Henry his brother, Richard.

As founder of the Boudicca Centre for Policy, Henry has established a programme to design and advance bespoke solutions aimed at supporting African efforts to strengthen democracy, good governance, economies, healthcare, education, transport, communications, manufacturing, security, the rule of law, sports and culture. As a British politician, Henry uses his influence to remind other politicians in the UK of the importance of Africa and the role it has to play in international affairs and the global economy.

International Diplomacy

Henry has led international efforts to assist fourteen countries to overcome various forms of conflict and crises. He has helped to bring transparency to political,

government and democratic processes and has drafted a number of strategies and roadmaps that have guided the countries he has helped.

Furthermore, Henry has served as a United Nations District Administrator; Head of International Ceasefire Monitoring Operations in the Balkans and as adviser to a number of government ministers and to the Secretary General of the 57 member state Organisation for Security & Cooperation in Europe.

### **Politics**

Having been involved in UK politics since 2005 Henry founded The Our Nation Party in March 2018. The objectives of the Party are to unite the country after a divisive Brexit debate; to deliver the most effective solutions to the day-to-day challenge of individuals, communities and businesses throughout the UK; to ensure that the UK leaves the EU on a trajectory that builds the confidence, optimism, prosperity and security of the British people.

### Honours & Awards

Henry passed out from the Royal Military Academy Sandhurst as best overall cadet. He was commended for outstanding bravery by the police and was made an Officer of the Order of the British Empire by the Queen for services to international security.



# H.E Dr. Jewel Howard Taylor

Vice President of Liberia

Vice President Chief Dr. Taylor is a daughter of Bong County, born to the Royal Household of Kerkula Giddings of Sanoyea District. King Giddings in his tenure wrote the script to the Kpelle language. The Vice President was raised as a child on the Phebe Hospital Compound under the watch of her loving parents, Mr. Moses Y. Howard and Mrs. Nora Giddings-Howard., both of whom were enviable professional Health Workers who died in service to the people of Bong County and are buried at the Phebe Compound.

Vice President Chief Dr. Taylor is a visible and very involved stateswoman; with a vision for affordable but quality education; transparent justice system; improve and accessible health system; women's economic and political participation; and an accountable public service system. She is one of Liberia's foremost advocate for increased and improved opportunities for

women of Liberia; thus becoming a critical voice on cross-cutting issues at many frontlines in the battle to reposition Liberia for vibrancy, productivity and democratic good governance. On account of her national disposition, the Vice President is fondly called the Vice President without boundaries. While she represents Bong County in particular, her voice and views are national in scope.

Dr. Taylor currently serves in many capacities; Vice President of the Republic of Liberia and also served as senior, Ranking Member of the Liberian Senate serving on several strategic committees.



## Engr. Dr. Emmanuel Audu- Ohwavborua (FNSE, PMP)

Chairman of Emmppek Farms Ltd

Engr. Emmanuel Audu-Ohwavborua is a public administrator, a civil servant, a certified Project Manager, an entrepreneur, and a Fellow of the Nigeria Society of Engineers (FNSE). He is currently the Director of Bayelsa State office, Niger Delta Development Commission (NDDC), a public sector organization established to address the developmental deficits of the impoverished oil-bearing Niger Delta region of Nigeria.

With degrees in electrical engineering and business administration, as well as professional certifications in Project Management, he has had over 30 years' experience working in diverse sectors ranging from engineering designs, industrial and production management, through power plant engineering to project management. He also in March 2019 bagged a Doctor of Business Administration (Project Management) award from the Commonwealth University at a ceremony that took place in Dubai, United Arab Emirates. About one third of his service years, he invested in the private sector having worked in Dresser Kellogg Energy Services Ltd, Granherne Ltd and in Bonny Allied Industries Ltd. He also worked at the now defunct National Electric Power Authority (NEPA) and the National Engineering & Technical Company (NETCO).

A fast-growing entrepreneur, he is the Chairman of Emmppek Farms Ltd, a privately owned commercial agricultural enterprise (with specialty in both animal and crop production), located in the South-South of Nigeria.

His idea to make Global chamber of business leaders is one such example which is built on vision of business for peace and wellness. Prof. Nabhit has also been featured in some of the world leading publications.




# Ayan Mahamoud, MBE


